Pursuant to Regulation 30 of Listing Regulations, this is to inform you that Mahindra World City (Jaipur) Limited (MWCJL), a 74:26 joint venture between the Company and Rajasthan State Industrial Development and Investment Corporation Limited (RIICO), a Government of Rajasthan enterprise, respectively, has received an order from the Office of the Deputy Commissioner, Rajasthan dated 26<sup>th</sup> September, 2023 imposing a penalty of Rs. 1,73,579 for the tax period 2017-18 (July 2017-March 2018) towards violation of provisions relating to ITC availment under applicable provisions of RGST Act, 2017, CGST Act, 2017, IGST Act, 2017 read with rules made thereunder during the said tax period. Hence such credit is disallowed by the Authorities for the said tax period.

Based on internal assessment, prevailing laws, and basis tax expert's advice, MWCJL does not reasonably expect the said order to have any material financial impact.

The details of the said orders, as required under Clause 20 of Para A of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated 13 July, 2023 are enclosed as Annexure A.
