असा आमचा दावा नाही. मात्र अनेकदा नावे सारखी असली तरी दोन स्वतंत्र व्यक्ती असू शकतात. राजकीय पक्ष थेट आरोप करू शकतात, मात्र आयोग म्हणून आम्हाला त्या मतदाराचे एकापेक्षा अनेक ठिकाणी नाव आहे का, की एकच नाव असलेल्या दोन स्वतंत्र व्यक्ती आहेत का? याची प्रत्यक्ष पाहणी करावी लागते. आयोगाच्या निवडणूक कर्मचाऱ्यांनी सध्या प्रत्यक्ष पाहणी सुरू केली आहे. त्यानुसार प्रत्येक प्रभागाला मतदारादीसोबत दुबार मतदारांची यादी देखील पाठवण्यात आली आहे. मतदाराच्या पत्त्यावर प्रत्यक्ष पाहणी करून त्यानिष्पत्तीची खात्री ते करणार असल्याचे त्यांनी सांगितले.

तात्पुरता उपाय

नगरपरिषद- नगरपंचायत निवडणुकांसाठी जाहीर झालेल्या मतदारयादीवर असंख्य हरकती असलेली मतदारयादी आयोगाने जाहीर केली आहे. या निवडणुकीत वापरल्या जाणाऱ्या मतदारयादीवर ५० हजाराच्या आसपास हरकती आल्या होत्या. त्यापैकी ३० टक्के हरकती मतदारयादीत असलेली दुबार नावे, बेगस नावे, मूत व्यक्तींची नावे यादीत कायम असणे, मतदार यादीतील पत्त्यावर ती व्यक्ती राहत नसण्यासारख्या हरकती नोंदवण्यात आल्या होत्या. तर चुकीच्या प्रभागातील मतदारयादीत नाव असल्याच्या ७० टक्के हरकती होत्या. मतदार यादीतील नावे वगळणे किंवा यादीत समावेश करण्याचा अधिकार राज्य निवडणूक आयोगाकडे नाही. त्यामुळे आयोगाने ३० टक्के हरकतीचा निपटारा करण्याऐवजी त्यावर तात्पुरता उपाय स्वीकारला आहे. उदाहरणार्थ, नाव दुबार असेल तर त्या नावासमोर विशिष्ट चिन्ह टाकले जाणार आहे.

याप्रकरणी अनंत सिंह यांच्या विरोधात एफआयआर दाखल करण्यात आला होता. पाटणा पोलिस अधीक्षक आणि त्यांच्या पथकांने बाद येथील कारागिरि मॉकॅट परिसरात छाप्यालत, अनंत सिंह यांना ताब्यात घेतले. दुलारचंद यादव यांच्या हत्येनंतर पोलिसांनी तपासाची गती वाढवली असून, बिहार पोलिसांची

गुन्हे अन्वेषण शाखा (सीआयडी) हे प्रकरण पाहत आहे. गोळीबार आणि हत्येनंतर या घटनेमुळे परिसरात तणाव निर्माण झाला आणि सोशल मीडियावरही तीव्र चर्चा झाली.

निवडणुकीच्या प्रचारादरम्यान ही घटना घडल्याने विविध भागांत राजकीय आणि जातीय समीकरणांवर नवे वादंग निर्माण झाले आहेत. दरम्यान, राज्याचे पोलिस महासंचालक विनय कुमार यांनी सांगितले की, या प्रकरणात आतापर्यंत ८० जणांना अटक करण्यात आली आहे. मोकामा येथील जनसुराज पक्षाचे उमेदवार पीयूष प्रियदर्शी यांच्या प्रचारादरम्यान दुलारचंद यादव यांची हत्या करण्यात आली होती.

‘मोल’ गृहिणीच्या कामाचे

काही दिवसांपूर्वीचा प्रसंग. आम्ही महाविद्यालयातील मित्रमंडळी बऱ्याच दिवसांनी एकत्र जमलो होतो. हास्यविनोद चालू होते. सगळ्यांची मुले, सध्या ज्यांना ‘चुणचुणीत’ म्हणतात, तीदेखील सामील झाली होती. काम-धंद्याबरोबरच घरातले कामही सर्वांनी वाटून घेतले पाहिजे, असा विषय चालू असताना एक मुलगा म्हणाला, “घरकाम हे काही आमचे काम नाही; ते आई करते, मी बाबासारखा मोठा बिझनेसमन होणार, तो खूप काम करतो आणि पैसे कमावतो ...” क्षणभर एकदम शांतता पसरली आणि आमच्या मैत्रिणीच्या डोळ्यात टचकन पाणी आले. यानिमित्ताने “‘होय, गृहिणीच्याही कामाचे मोल असतेच’”, असे नमूद करणाऱ्या सर्वोच्च न्यायालयाच्या एका महत्त्वपूर्ण निकालाची आठवण झाली.

न्यायालयापुढे विषय होता तो डेअ्यू आजारवरील उपचारांबाबत झालेल्या निष्काळजीपणाचा. ‘अरुणकुमार मांगलिक विरूद्ध ‘चिरायू हेल्थ आणि मेडिकेअर प्रा. लि.’ या खटल्यात राष्ट्रीय ग्राहक आयोगाचा निर्णय फिरवताना सर्वोच्च न्यायालयाचे न्या. धनंजय चंद्रचूड आणि न्या. हेमंत गुप्ता ह्यांच्या खंडपीठाने डेअ्यू रुग्णाच्या मृत्यूस कारणीभूत उरल्यामुळे तब्बल १५ लाख रुपयांचा दंड भोपाळमधील एका रुग्णालयाला ठोठावला, मात्र संचालक डॉक्टरांची निष्काळजीपणच्या आरोपातून मुक्तता केली. या प्रकरणात राज्य आयोगाने नुकसान भरपाई देताना नमूद केले होते की, मयत महिला ही एक गृहिणी होती आणि त्यामुळे रु. सहा लाख एवढी रक्कम पुरेशी होईल. मात्र सर्वोच्च न्यायालयाने नमूद केले की, आपल्या अधांगिनीला असे अचानक गमावणे, ह्यासारखे दुःख कोणत्याही नवऱ्याला नसेल. जर कमावती महिला असेल तर तिचे उत्पन्न किती हे सहज काढता येते. मात्र सर्व घर सांभाळणाऱ्या गृहिणीचे काम हे कुटुंबाच्या कल्याणाकरिता खूप महत्त्वाचे असते आणि तिच्या कामाचे आणि भावनांचे मोल जाणायला हवे. अशा स्वरूपाच्या खटल्यांत ते पैशात मोजणे काही गैर नाही. हाच विचार करून आणि गृहिणीचे महत्त्व अधोरेखित करीत

याचिकारत्यांस १५ लाख रुपयांची भरपाई नऊ टक्के व्याजासह देण्याचा हुकूम दिला. अशाच स्वरूपाचा निकाल अलीकडेच न्या. सूर्यकांत (जे पुढे सरन्यायाधीश होणार आहेत) आणि न्या. के. व्ही. विश्वनाथन यांच्याही खंडपीठाने देताना गृहिणीचे काम हे कमावल्या कौटुंबिक सभासदाच्या योगदानाइतकेच महत्त्वाचे असते, असे नमूद केले आहे.

खरेतर गृहिणी असणे हे खूप महत्त्वाचे आणि जबाबदारीचे काम आहे. ‘ऑन ड्युटी २४ तास’ असे हे कामाचे स्वरूप. आजपर्यंत बहुतांशी मध्यमवर्गीय घरांमध्ये आईने घरची आघाडी सांभाळायची आणि वडिलांनी बाहेरची असे चालू असे. त्याचप्रमाणे अनेक घरांमध्ये स्वतःची नोकरी सांभाळून गृहिणींची भूमिका व्यवस्थितपणे पार पाडलेल्या अनेक महिला आपल्या आजूबाजूला दिसून येतील. घरच असा आहे की, धरकाम करणे म्हणजे दुय्यम आणि पैसे मिळविणे म्हणजेच महान असा समज

मुलांचा होत असेल किंवा आपल्याकडून कळत-न कळत करून दिला जात असेल, तर ते चुकीचेच आहे. आपला समाज असे वर्गीकरण करण्यामध्ये एकदम पुढे असतो. उदा. मुलगी झाली की गुलाबी रंगाचे कपडे आणि भेट म्हणून बाबीं आणि मुलगा झाला की निळ्या रंगाचे कपडे आणि गाड्या भेट द्यायच्या, असा शिरस्ता कदाचित अशाच साचेबद्ध विचारपद्धतीतून पुढे आला

आहे. कायदा आणि न्यायालयीन निर्णय गृहिणींचे महत्त्व सांगतात, परंतु समाजात सर्वदूर ती मानसिकता निर्माण होणे महत्त्वाचे. नुसत्या कायद्याने स्त्रियांच्या परिस्थितीत बदल होणार नाही. घरकाम म्हणजे महिलांचा इलाका असे वर्गीकरण असणाऱ्या समाजात काही घरांमध्ये, बाबादेखील ‘होममेकर’च्या भूमिकेत असल्याचे आणि बाबाने ही भूमिका नीट पार पाडल्याचेही दिसून येते. स्वतः उच्च विद्याविभूषित असूनही काही जण ही संवेदनशीलता आणि जाणीव दाखवतात. ती अनुकरणीय आहे. पण त्यांनाही ‘बायकी कामे करतो’ असे टोमणे मारणारे लोक आहेत. पण अशा टीका-टिप्पण्यांकडे दुर्लक्ष करणेच श्रेयस्कर
